**The applicant shall submit the following information:** (Check all that are applicable and included)

- Bond – to be given to the City in the amount of two thousand dollars (\$2,000.00) with sufficient sureties, conditioned that the person obtaining such license shall at all time abide by the provisions of the Liquor Control Act of the State of Missouri and all ordinances of the City of Green Park.
- Bona fide sale contract or option duly executed for the property for which a liquor license is requested.
- Bona fide lease duly executed by the lessor or an option for lease duly executed for the property for which a liquor license is requested.
- Partnerships:
  - Names and address of all partners.
- Corporations:
  - Names and address of all managing officer(s), officer(s) and identify such officer(s).
  - Names and addresses of all shareholders.
  - If corporation operates any other business or controls or is controlled by any other corporation or business, the application shall further provide the name of such controlled or controlling corporation or business, its registered agent and registered address, and the location of all businesses operated by it and the name and address of any such businesses with a liquor license, whether within or without the City; and the application shall also state if such controlling corporation or any controlled corporation is doing business under a fictitious name, and the address where said business is located.
- List of properties within a distance of two hundred (200) feet from the proposed location in all directions and said list must be signed by a majority of those property owners stating they approve. *(Only required for new applications)*

*Additional Information -- The City reserves the right to request additional information deemed necessary to make a determination regarding the issuance of a liquor license.*

*Application for Original License -- All applicants for new liquor licenses shall be subject to a hearing before the Board of Aldermen conducted pursuant to Section 600.090 of the Green Park Municipal Code.*

**Applicants Affidavit:**

Applicant hereby swears, affirms that neither he/she, nor any officer, director or shareholder of a corporate applicant have been convicted of a felony or of any distribution, sale or possession of any controlled substances or dangerous drugs, been convicted since the ratification of the 21st Amendment to the Constitution of the United States of the violation of any law applicable to the manufacture or sale of intoxicating liquor, or that such applicant has not employed in his/her business any person whose license has been revoked or who has been convicted of violating the provisions of such law since the date aforesaid, and no license theretofore issued to such applicant to sell intoxicating liquors has been revoked within two (2) years of the date of the application.
